December 10th

Annual Investors call

Completed with Brenda/BKDV on 11/3/21. There was a third party this time, and several questions were asked around employees/resignations, waitlist clarification, and other challenges that are pandemic related. I believe this is the first time we have actually been joined by a representative.

District Advisory Committee meeting

Set for December 2nd at Bluffview in the bandroom. This committee must be held at least annually in alignment with the World's Best Workforce submission. The goal is to guarantee parents an opportunity to participate in discussions and decisions about the academic direction of the school.

Covid Plan update

The CH team and I made one change to the exceptions-item "C" was added: Exceptions can be made for the following categories of people:

- **A.** A person who <u>cannot wear a mask</u>, or <u>cannot safely wear a mask</u>, because of a disability as defined by the Americans with Disabilities Act (ADA) (42 U.S.C. 12101 et seq.)
- **B.** Children under 2 years of age should not wear a mask.
- C. Children's House students may, prior to exiting for outdoor activities during the "winter season", remove their face coverings at their hallway cubbies and leave them there. Teachers will ensure that the students line up in classrooms and maintain a minimum distance of 3' to the best of their ability. Re-entry to the building will take place at the main entrance. Students will be encouraged to maintain the full 3' of spacing between individuals, remove their winter boots on the rug, proceed to their cubbies and remove hats. Then masks will be put on, and the rest of the outdoor gear will be stowed in cubbies as directed by the staff.

ESSER III application

Still no word. We are at a point where we need to start planning-getting probably 2 individuals in place to get this work started.

Planning to hire a Recovery Coordinator, leader for a Gender equity and support group we have been planning, and adding Mindfulness and other services with Manitou for staff and parents.

Employee Assistance Program

Subs/staffing

Short call sub pay up to \$120 for teachers. Add went out for 2 weeks in the paper for several positions, and the regular other postings along with emails to University staff that may be of help. We do have one teacher out on FMLA (being covered by our in-house sub for now), and another that has been in and out due to some medical issues. So far we have been able to cover them. Otherwise, staff attendance has been strong.

OSHA ETS-not applicable to us

Minnesota OSHA receives federal OSHA emergency temporary standard
State OSHA Plan has 15 days to review, 30 days to adopt
The federal Occupational Safety and Health Administration (OSHA) will publish a COVID-19
Vaccination and Testing Emergency Temporary Standard (ETS)
(http://www.osha.gov/coronavirus/ets2) in the Federal Register on Nov. 5, 2021.

The ETS requires all employers with 100 or more employees to ensure their workforce is fully vaccinated or require those who remain unvaccinated to produce a negative test result on at least a weekly basis.

Minnesota OSHA (MNOSHA) Compliance has received the ETS and will review the details of the new rule.

As an OSHA-approved state plan, MNOSHA must be as effective as federal OSHA in enforcing safe and healthful working conditions.

MNOSHA needs to notify federal OSHA of the action it will take within 15 days and adopt an ETS that is at least as effective as the federal OSHA ETS within 30 days after the final federal rule is published Nov. 5 in the Federal Register.



Media Call on Tuesday, 11/16/2021

- MN is the new COVID-19 hotspot
- Minnesota's rate of new coronavirus infections has been worst in the nation over the past seven days
- MN is second in the nation for booster shots delivered
- Pediatric cases are rising; 1 in 100 children will be hospitalized
- 22% increase in children testing + for COVID-19 in the last week
- MN had its fifth death in a person under 19-years-old in the last week

Media Call on Tuesday, 11/16/2021

- Schools who do not mask are 3.5 times more likely than masked schools to have an outbreak. Source: Sheldon Berkowitz, AAP
- Continue/ re-implement the 9/10 mitigation factors in schools recommended by the CDC and MDH
- MDH is predicting the surge will not be as high as last fall but will last longer; too early to say the surge won't be worse
- Delta variant is considered a super-spreader; 1 case begets 7 cases
- With such a high vaccination rate, why is MN the worst? Too soon to know but could be a combination of more people staying indoors at the same time that immunity in adults is waning
