# Potential SEL grant

We are being considered for the SEL grant I applied for through the state-it is a 3 year grant cycle that will train teachers in the delivery of a research based SEL program. Would be grade 6 next year, grade 7 the following year, grade 8 after that. They pay for all training, including an external fidelity monitor. Our site visit is scheduled for 9/25/19.

# DHS

DHS added a risk assessment to the pre-k requirements. Katie and I reviewed it, filled it out, had the staff review it and put a copy in each classroom DHS binder. It was added to my spreadsheet checklist for the annual spring DHS visit.

## GiveMN/MACS

I helped organize a "how to" meeting at MACS with GiveMN to offer Charter schools help in creating some fundraising opportunities for their schools. I attended on the 12th, and have some better ideas to move forward with the creation of the fundraising committee this winter.

Last year Ann Marie, Amanda Hedlund and I started a chart of the school's "fundraising asks," and there are quite a few. The goal of the fundraising committee will be to, in my mind, eliminate some of the events (cookie dough, BB&B, etc.) and do an annual ask built around Give to the Max Day.

#### Mission Statement work

Some work was done on the Mission, and it was rather frustrating to try and piece together, so I offered it to a friend that is a skilled wordsmith. I offered the draft to my team, but have not had any response.

Here it is: Bluffview Montessori School empowers self-directed learning through a multi-sensory, materials-based Montessori curriculum that, in all learners, germinates an independent diligence, nourishes our natural curiosities, and enroots a deep respect for self, community, and environment, sprouting the intrinsic desire for scholastic, civic, and personal fulfillment.
