**Policy 540** -- discussion around item IV.C.5. Kindergarten red shirting. Concern around using language for age 6 to define. Suggested Language-- "delaying kindergarten by one year (kindergarten redshirting) is allowed at the request of parent, but is discouraged"

Add an item under 4.A to clarify parents must submit application for one grade only 4.D.6 change language that students "will apply to grade 1"

**Policy 604** - II.A. Discussion around punctuation and missing words to help make that sentence make sense. Specifically parts 5 and 6. Discussion around "the arts" vs "fine arts"
