4- Open Forum

Heather Teichroew -- concerns about mental health and masks impact on student learning and mental health. Over time +1:22

Susan Koo -- Mental health, son has developed depression, many of their other children struggle with wearing masks. "Perceived risks" - children are at minimal risk. Believe Covid is real, masks should be optional. Over time +0:22

Jo Koo -- Board Certified Emergency Medicine Professional: gives summary of data and research showing that masks have minimal impact on spread of Covid. Over time +4:05

Stefanie Boebel (not wearing mask during meeting) -- masking should be optional. Cites risks of dying of Covid is minimal, causes mental health toll. Students (own child) with disabilities need to see whole face for developmental and speech needs. WHO recommendation up to 5yrs should not wear masks. Over time +2:25

Annie Casselman (not wearing mask during meeting) -- Student with significant disability needs to be able to see people's full face to communicate and understand her surroundings. No overage

AJ Crawson (not wearing mask during meeting) -- talks about testing, false/positives negatives, CDC study shows masks does not limit influenza transmission. Mask mandates should not be based on positive cases. No Overage

Carrie Heckman -- concerns about mental health, and mentions low risk to children. No Overage

Davin Heckman -- Used to support masks, over time opinion has changed. Mentions that you can find studies for either side. Describes how his youngest children are losing interest in school and having negative connections to school due to masks. Creating too much responsibility placed on children. Weigh real harms vs. hypothetical possibilities. Over time +1:46
