ARTICLES OF INCORPORATION OF BLUFFVIEW SCHOOL, A MONTESSORI LEARNING CENTER

We, the undersigned, of full age, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 317 of the Statutes of Minnesota, known as the Minnesota Non-Profit Corporation Act, do hereby associate ourselves as a body corporate and adopt the following Articles of Incorporation:

The name of this corporation is Bluffview School, A Montessori Learning Center.

The purposes of this corporation shall be to create a quality Montessori school for children, to foster and promote the welfare of the child, to stimulate research and development in Montessori education both for the Montessori community and for the general educational community, to educate parents so that they can assist in the education of their children, and other related services of an educational and literary nature.

The corporation shall not participate in nor intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation.

This corporation does not and shall not afford pecuniary gain, incidental or otherwise, to its members. This corporation is irrevocably dedicated to, and operated exclusively for, non-profit purposes.

This corporation shall have perpetual duration and existence.

Merger Agreement

Bluffview School - A Montessori Learning Center and Montessori of Winona (previously known as Delahanty Montessori School, and as Montessori School of Winona), both non-profit corporations of Winona, Minnesota, hereby agree to the following:

- 1. The two schools will merge on September 29, 1989. Bluffview School
 A Montessori Learning Center will be the surviving corporation.
- 2. The new, merged school will be named Bluffvlew Montessori School and will adopt the bylaws which have already been adopted unanimously by both boards of directors.
- 3. All property owned by Bluffview School A Montessori Learning Center and by Montessori of Winona and all obligations will be transferred to Bluffview Montessori School. There are no shares in either corporation. Any and all present members of either school will become members of Bluffview Montessori School.
- 4. In the event that the corporation dissolves, an attempt will be made to allocate all property, holdings, and obligations in the fairest and most equitable way. A careful attempt should be made to maintain the integrity of any and all classrooms. In case of any sale following such a dissolution all monies should first be allocated to the establishment of an adequate retirement or pension plan for all employees, the details of which would be worked out by the principal, president of the board of directors and a representative of the school's bank.

5. All of the signatories to this agreement agree that they would not individually or collectively use the names or logos of Bluffview School - A Montessori Learning Center, Montessori of Winona, Delahanty Montessori School or Montessori School of Winona in setting up or organizing any school in the Winona area competitive to Bluffview Montessori School. Bluffview Montessori School is, however, free to change its name to any of these by the usual process.

This agreement was adopted in accordance with the provisions of 317.30 - 317.42 of the Minnesota statutes, and in accordance with the bylaws of both of the constituent corporations. A resolution was adopted on August 29, 1989 by the boards of directors of both constituent corporations approving this Merger Agreement and directing that this agreement be submitted to a vote of the memberships of each corporation at a special meeting to be called for that purpose. This agreement was adopted by a majority vote of the membership of Montessori of Winona at a special meeting held on September 7, 1989; and by a majority vote of the membership of Bluffview School - A Montessori Learning Center held on September 7, 1989.
