The Cost of Authorizing Minnesota's Charter Schools for 2019-2020 (FY 20)

Annual Authorizers Income and Expenditures Compilation Report

A Publication of the Minnesota Association of Charter Schools

History of Authorizer Income & Expenditures

Among the many accountability reforms enacted to Minnesota's second-generation charter school law in 2009, were two specific provisions that addressed the cost of authorizing.

The first provision established a new fee structure and significantly increased potential oversight fees paid by schools to authorizers. The increase was phased in over a four-year period. Today, over \$3 million dollars per year is paid by schools to authorizers for their oversight responsibilities.

The second provision established a requirement that authorizers annually submit by September 30th a report of their oversight expenses for the previous charter contract/academic year to the Commissioner of Education, as well as to the schools the authorizer charters. The expenditure reports are designed to ascertain the real cost of authorizing, as well as to ensure that funding for authorizing responsibilities is not being diverted for other operations of an authorizer.

These two provisions went into effect on August 1, 2009. Given there was no reporting requirement prior to the change in law, the first reports should have been due on September 30, 2010, for the 2009-2010 (FY10) charter contract year.

That fall, the MN Association of Charter Schools made multiple requests to MDE for those reports. It was unclear whether the authorizer expenditure reports were ever requested or collected by MDE as it did not have copies of the reports in its data base and was not able to locate hard copies of these reports. So, it was impossible to compile a report on authorizer expenditures for FY10.

While MDE began formally requesting the authorizer expenditure reports in FY 11, authorizers were slow to comply with the requirements in the law.

•In FY11, only 18 of 40 plus authorizers submitted the required expenditure report.

- •In FY12, 26 of the 37 authorizers submitted the required expenditure reports.
- •In FY13, 19 of the 25 authorizers submitted the required expenditure report.

In 2013, the charter school law was amended to require that authorizers not only report expenditures but also their income including the fees paid by the schools. So, beginning with FY14, authorizer reports were to include the reporting of income.

Since then, there have been two challenges in getting a complete picture of the income and expenditures of authorizing.

One, there is no standardized required reporting form, so how expenses are categorized and reported varies with each authorizer.

Two, authorizers that have withdrawn as an authorizer have not submitted a report for their final year of authorizing. This continues to occur and needs to be addressed by MDE or through legislation.

Overview - FY 20

1] All but one authorizer (Student Achievement Minnesota) reported more income than expenditures in FY20.

2] The Total Net Income of authorizers in the last 4 Fiscal Years is \$737,590.46

•FY20: \$199,971.30 •FY19: \$76,200.01 •FY18: \$228,474.02 •FY17: \$232,945.13

3] Average Per School Oversight Cost:

•FY17: \$16,738.57

•FY 20: \$18,556.50 - an increase of \$1,817.93 or 11% since FY 17.

Recommendations

Based on history and a review of financial reports over the kast several years, The MN Association of Charter Schools makes the folloing recommednations:

- 1] MDE enforce the charter school statutory provision which requires all authorizers (including an authorizer's last year as an authorizer) to submit an income and expenditures report. If MDE does not believe it has the statutory authority to do so, the charter school law provision regarding authorizer financial reports should be amended to give MDE the authority to enforce this requirement.
- 2] Upon an authorizer's withdrawal as an authorizer, any fund balance the authorizer has from authorizer fees must be returned to the schools it authorized as those public funds were for the specific purpose of authorizer oversight.
- 3] MDE modify the Authorizer Annual Income and Expenditure Reporting Form to require authorizers to account for fund balances from the previous reporting year.
- 4] MDE require the use of a standardized Authorizer Annual Income and Expenditure Reporting Form by all authorizers.
- 5] MDE include a review of the authorizer's use of authorizer fees from schools as part of the MN Authorizer Performance Review Process.
