- Completed Verification for free and reduced lunch applications. Process required each year by MDE that verifies a percentage of the free and reduced lunch applicants.
- MARSS Submission: First fall submission of the year was 9/24/19. Final end of year 2019 was October 16. I continue to work on learning how to use Ed Fi, which will eventually replace the present MARSS submissions. We are now using the new EDIAM system, but because JMC is not ready, we are unable to be submitting our files through Ed Fi. This year, we will need to submit in both MARSS and EdFi. If our comparison reports are positive, we would be able to use only EdFi next year. (MARSS submissions allow us to get our state/federal funding, sped funding)
- Our 3 year food service review with MDE is this year. I have been working on submitting the required information for both the phone conference on October 23 on site visit (November 5-6).
- I have been working to start MA (medical assistance) or third party billing for Bluffview. Paperwork has been submitted to Health and Human Services, and we are waiting for approval from them. Para professional has completed PCA (personal care assistant) training. The next step will be to complete a time study and get set up to track billable expenses. Third Party Billing is a program where Bluffview can be refunded for billable expenses, including PCA services for special education students, speech and language services, and some school psychologist fees.

- Fall Sharing on October 8 We had a great turnout for fall sharing and breads 'n spreads afterward.
- Fall Festival will be on October 26 at Briggs Farm. I have been working with a parent committee in planning activities.
