



Charter School Pledge of Compliance to Authorizer for FY25

This document is a pledge to the school's authorizer, VOA-MN, that the school is, and will continue to be, in compliance with all Minnesota Statutes pertaining to Charter Schools. The current board chair and school leader must sign the top of the document and initial each individual item, certifying that the school complies with the indicated laws. In some cases, additional documentation must be supplied to further substantiate fulfillment of the law. For that purpose, the VOA-MN Compliance Binder should contain documentation of a public nature as proof of statutory compliance and be available on-site for authorizer review during formal site visits. Any non-public information should have its secure location listed (e.g., Results of background checks can be found in a locked file cabinet in the director's office.).
