

## HEALTH AND SAFETY LAWS APPLICABLE TO MN CHARTER SCHOOLS

## **INTRODUCTION**

Minnesota's Charter School Law [MN Statutes 124E.03 subd.2 (a)] states that; "A charter school shall meet all federal, state, and local health and safety requirements applicable to school districts".

Given the scope of the laws regarding federal, state and local health and safety laws and requirements that are applicable to traditional school districts, the legislature did not enumerate these requirements in the charter school law.

Thus, it is incumbent on the charter school board and administration to be aware and knowledgeable of the health and safety laws that apply to public schools. In fact, under Minnesota's Nonprofit Law (MN Statutes 317A), a board of directors has a fiduciary duty (Duty of Obedience) to be acquainted with the laws that apply to their organization.

This **Guide to State & Federal Health & Safety Laws Applicable to Minnesota's Public Charter Schools** is a compilation of laws designed to be a reference tool for boards and administrators. The Guide identifies state and federal health and safety laws, provides a brief statement of the significant requirements of the law, denotes the statutory reference so you can look up the law, and indicates whether the law requires the school to have a written policy.

We hope that this Guide provides charter school boards and administrators a solid foundation for meeting their obligation to comply with all federal and state health and safety requirements.

MN Statutes 121A.03	Sexual, Religious, Racial Harassment & Violence Policy	Requires a school board to adopt a written sexual, religious and racial <b>harassment</b> policy and sexual, religious and racial <b>violence</b> policy that conforms with the MN Human Rights Law - Chapter 363A	
MN Statutes 121A.035	Crisis Management Policy A school board and a charter school must adopt a crisis management policy to ad potential violent crisis situations in the district or charter school. The policy must be dever cooperatively with administrators, teachers, employees, students, parents, commembers, law enforcement agencies, other emergency management officials, c attorney offices, social service agencies, emergency medical responders, and any appropriate individuals or organizations. The policy must include at least five school down drills, five school fire drills consistent with section 299F.30, and one tornado drill.

MN Statutes 121A.16-19	Early Childhood Development Screening	Defines the purpose of and outlines board responsibilities and amount of aid for charters offering early childhood development screening programs. Programs must comply with this law to be eligible for aid.	
MN Statutes 121A.21	School Health Services	Every school board must provide services to promote the health of its pupils. When ADM enrollment is more than 1,000, the school board must employ or contract for the services of a licensed school nurse, or enter into another Commissioner-approved arrangement.

MN Statues 121A.24	Seizure Training & Action Plan	Schools must have a seizure action plan for each student that has been diagnosed seizure disorder. The law outlines the requirements for plans and training that must be provided for staff.	
MN Statutes 121A.25-29	<b>Chemical Use &amp; Abuse</b> Every public school that participates in a school district chemical abuse program must establish a chemical abuse preassessment team. The legislation includes provisions a the preassessment team and requirements for referring of students.

Johnson Right to Know)	A school that plans to apply a pesticide which is a toxicity category I, II, or III pesticide product, as classified by the United States Environmental Protection Agency, or a restricted use pesticide, as designated under the Federal Insecticide, Fungicide, and Rodenticide Act, on school property, must provide a notice to parents and employees that it applies such pesticides.	
MN Statutes 121A.31	School Lab Safety	Schools must comply with state fire marshal guidelines for school labs. (Lack of funding is not an allowable excuse for non-compliance.)	
MN Statutes 121A.32	Wearing Eye Protective Devices	Requires individuals to wear industry quality eye protective devices when participating in any courses or activities taking place in eye protection areas, including vocational or industrial art shops and science or other school laboratories.	
MN Statutes 121A.323	Concussion Procedures	Requires schools (including charters) to provide parents and guardians information about nature and risks of concussions and the effects of continuing to play after receiving a concussion.	
MN Statutes 121A.33	Mercury Use in Schools	Prohibits schools from purchasing, using or storing elemental mercury or a measurement too containing mercury, including a thermometer or barometer.	
MN Statutes 121A.336	Notification of Environmental Hazard	Upon notification by MDH or the Pollution Control Agency of an environmental hazard that may affect the health of students and staff, the school must notify staff, students and parent of the potential hazard, and provide them with information on the hazard and what action is being done to reduce the potential hazard.

MN Statutes 123B.56	Health, Safety & Environmental ManagementRequires that school districts conduct activities necessary for a district's compliance with state law and rules of the Departments of Health, Labor and Industry, Public Safety, and Pollution Control Agency as well as any related federal standards. These activities include hazard assessment, required training, record keeping, and program management.		
MN Statutes 123B.71-72	Review & Comment for School District Construction Requires review & comment by commissioner for school construction over a certain an This applies to the construction of new charter school buildings through affiliated building companies.		
MN Statutes 123B.72	School Facility Commissioning	Prior to occupying or reoccupying a school facility, a school board or its designee shall submit a document prepared by a system inspector to the building official or to the commissioner verifying that the facility's heating, ventilation, and air conditioning system has been installed and operates according to design specifications and code.	
MN Statues 123B.885	School Bus Idling All diesel school buses must minimize idling and must be parked and loaded at sufficient distance from air-intake system of the school.

MN Statutes 123B.90 -91	School Bus Safety	Requires written pupil transportation safety policy. If a charter school utilizes district transportation, the charter school and its students are bound by the district policy.
MN Statutes 124A.336	Notification of Environmental HazardUpon notification by MDH or the Pollution Control Agency of an environmental ha may affect the health of students and staff, the school must notify staff, students of the potential hazard, and provide them with information on the hazard and what being done to reduce the potential hazard.	
MN Statutes 124D.166	Limits on Screen Time – PreK & Kindergarten	A student in a publicly funded pre-school or kindergarten may not use an individual-use screen (example: tablet, smart phone, etc.) without engagement from a teacher or other students. This does not apply to students with an IFSP, an IEP or a 504 Plan.
MN Statutes 125B.15	Internet Access Safety	Requires schools to have software filtering technology on ALL computers with Internet access available for student use.
MN Statutes 144.29	Health Reports	Requires every school nurse, school physician, school attendance officer, superintendent of schools, principal, teacher, and the persons charged with the duty of compiling and keeping the school census records to cause a health record to be kept for each child of school age. Such record shall be kept in such form that it may be transferred with the child to any school which the child shall attend within the state.

MN Statutes 144.4165	Tobacco Products Prohibition in Public Schools Act	No person shall at any time smoke, chew, or otherwise ingest tobacco or a tobacco product, or carry or use an activated electronic delivery device in a public school, as defined in section or in a charter school governed by chapter 124E, and no person under the age of 18 shall possess any of these items. This prohibition extends to all facilities, whether owned, rented, or leased, and all vehicles that a school district owns, leases, rents, contracts for, or controls. Nothing in this section shall prohibit the lighting of tobacco by an adult as part of an American Indian spiritual or cultural ceremony.
MN Statutes 144.441	Tuberculosis Screening in Schools	Allows commissioner of health to designate schools in which tuberculosis screenings of students or staff is a necessary public health measure.
MN Statutes 144.442	Tuberculosis Testing in School Clinics	Outlines the requirements and rules for doing tuberculosis testing in the schools.
MN Statutes 144.45	Tuberculosis in Schools - Certificate	No person with active tuberculosis shall remain in or near a school building unless the person has a certificate issued by a physician stating that the person's presence in a school building will not endanger the health of other people.
MN Statues 157	MN Food Safety	Requires school kitchens to be licensed and inspected. School may, however, sponsor potlucks.
MN Statutes 182.676	Workplace Safety Committees	All employers of 25 or more employees shall establish and administer a joint labor- management safety committee. Employers of 25 or less employees must establish a safety committee under specific situations.

MN Statutes 326B.112	Bleacher Safety	Establishes safety requirements for bleachers in all public accommodations, and establishes schedule for periodic inspections.	
MN Statutes 626.556	Reporting Maltreatment of Minors	Requires reporting of physical and sexual abuse as well as neglect; identifies persons mandated to report, outlines investigation, notification and determination processes.

PL 107-110 Title IV Part A	Safe & Drug Free School Zone	Requires a drug free school zone of at least 1,000 feet from school property.
PL 107-110 Title IV Part A Section 4141	Gun-Free School Act	Requires expulsion of at least 1 year for possession of firearms on school property.
CFR 1904.32 U.S. Department of Labor	OSHA Accident Investigation Summary	Requires annual summary of injuries and illnesses be recorded on OSHA 300 Log.
